Chair Mandelbaum reviewed the minutes of the December 8, 2014 meeting, and the Council moved, seconded, and approved the minutes by a roll call vote.

### V. Councilmembers' Reports

Chair Mandelbaum announced that he will be on a panel at the San Francisco Bar Association's Yosemite conference where he will be discussing momentous employment law decisions of 2014.

### VI. Department of Fair Employment and Housing Report

#### A. DFEH Update

Acting Director Billotti discussed matters currently being handled by the Department and announced the start dates for the new Director, Kevin Kish, and new Chief Deputy Director, Joan Keegan.

#### B. Legislative Update

Acting Director Billotti reported on pending legislation, including AB 52 and AB 54, which each seek to amend the California Disabled Persons Act, and SB 67, which seeks to amend sections 55.54 and 55.56 of the Civil Code.

#### VII. Unmodified Text of Proposed Amendments to the California Family Rights Act Regulations

#### A. Discussion

Chair Mandelbaum and Councilmember Brodsky discussed the post-15-day comments and their rationale for concluding that no further revisions were necessary. They also discussed the timing for the adoption process.

Both commenters reiterated the written comments they submitted during the 15-day comment period.

C. Action by Council

The Council moved, seconded, and on a unanimous roll-call vote approved a motion to approve the Unmodified Text of Proposed Amendments to the California Family Rights Act Regulations and to authorize the Department to submit the rulemaking package to the Office of Administrative Law.

### VIII. Report of FEHA Employment Regulations Subcommittee

Councilmembers Brodsky and Perez reported on the process of reviewing public comments received during the 45-day comment period.

### IX. Report of the Education and Outreach Subcommittee

Chair Mandelbaum and Councilmember Perez reported on the progress of the Education and Outreach Subcommittee. Chair Mandelbaum reported on a recent appearance on a public radio program, Your Legal Rights, to address proposed amendments to the CFRA regulations. He suggested a similar outreach appearance during the FEHA employment regulations rulemaking process.

Councilmember Brodsky announced that she will be discussing the CFRA on a panel on January 30, 2015.

# X. Revised Conflict of Interest Code Regulation

### A. Discussion

Acting Director Billotti introduced the draft prepared by the Fair Political Practices Commission (FPPC) and recommended repealing the existing regulation and renumbering the new regulation so that it was relocated to the Administration subchapter of the regulations, adding to the consistency and clarity of the regulations.

Councilmembers Schneiderman and Franklin Minor reported on the Housing Regulations Subcommittee and the working draft of the text, and led a discussion on how to proceed in the process of drafting the text.

### B. Public Comment

The Council heard public comment on the text of the proposed Fair Employment and Housing Act Housing Regulations from:

Kelly Richardson, Richardson Harman Ober PC, Partner

- The goal should be to attempt to define existing law – not create new law. Recommends working on the draft one piece at a time. Likes the concept of the interactive process and believes there should be some requirement that a tenant participate in the process. Concerned about interjecting the idea of sexual harassment in housing as it is different from the employment setting. Concerned over the handling of medical marijuana smoke intrusion to adjacent neighbors. Would like to tie a health care professional's area of expertise to the reason for a comfort animal. Would love to see temporary disability addressed in the regulations.

Leah Simon-Weisberg, Tenants Together, Legal Director

- Concerned with occupancy standards. Believes the Council lacks the necessary housing expertise and should turn to housing groups like her own for their expertise. Sexual harassment in housing desperately needs to be addressed. The Council should start anew with the housing regulations once the new Director begins.

Brian Geiser, Oakland Tenants Union, Volunteer

- Concerned with occupancy standards as it will give landlords the ability to evict people who struggle to meet the two plus one requirement given rent affordability concerns.

Nadia Aziz, Law Foundation of Silicon Valley, Fair Housing Law Project, Senior Attorney

- Affirmed the Foundation's intent to provide formal comments during the rulemaking process and offered to participate in any working groups formed during the process.

# Paul Dumont, The Sober Living Network, Housing Advocate

- Concerned with occupancy standards.

Barbara Dickey, Disability Rights California, Associate Managing Attorney

- Sought clarification regarding the timing of formal comment periods for the housing regulations and encouraged the Council to utilize a working group.

Chair Mandelbaum announced that there is a tentative telephonic meeting scheduled for February, 17, 18, 19, or 20, 2015, and another in person meeting planned for March.
