# SECOND NOTICE OF MODIFICATIONS TO TEXT OF PROPOSED AMENDMENTS TO THE CALIFORNIA FAMILY RIGHTS ACT REGULATIONS

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Fair Employment and Housing Council (Council) is providing notice of further changes made to sections 11087-11097 covering the California Family Rights Act (CFRA).
