SECOND NOTICE OF MODIFICATIONS TO TEXT OF HOUSING REGULATIONS REGARDING HARASSMENT; LIABILITY FOR HARASSMENT; RETALIATION; AND SELECT DISABILITY SECTIONS, INCLUDING ASSISTIVE ANIMALS

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Fair Employment and Housing Council (Council) is providing notice of further changes made to sections 11098.1-11098.6 and 11098.23-11098.31 of Title 2 of the California Code of Regulations covering the Fair Employment and Housing Act. These further changes are attached and made in response to written comments regarding the proposed regulations received during the first 15-day public comment period that ended April 19, 2017. Text proposed to be added for the second 15-day comment period is displayed in double underline type. Text proposed to be deleted for the second 15-day comment period is displayed in double strikethrough type.
