SECOND NOTICE OF MODIFICATIONS TO TEXT OF HOUSING REGULATIONS REGARDING DISCRIMINATORY EFFECT, DISCRIMINATORY LAND USE PRACTICES, AND USE OF CRIMINAL HISTORY INFORMATION

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Fair Employment and Housing Council (Council) is providing notice of further changes made to sections 11098.04.1-11098.04.7, 11098.14.1-11098.14.4, and 11098.18.1-11098.18.10 of Title 2 of the California Code of Regulations covering the Fair Employment and Housing Act.
