## A. Discussion by Council

Councilmember Chan reported that the subcommittee has been reaching out to organizations that are actively engaged in combating hate violence and found that there is already much activity involving public education and public hearings. As a result, the subcommittee believes drafting regulations and holding hearings designed to solicit feedback on areas in need of regulations would be the best next steps.

The Council suggested gathering input from organizations that could be incorporated into future regulations, as well as booking a guest speaker to present on hate violence at the July 31 meeting.

## A. <u>Discussion by Council</u>

Chair Mandelbaum flagged that Councilmember Lisa Cisneros has left the Council to join the California Department of Justice. He then turned the meeting over to Director Kish to comment on a potential new subcommittee.

Director Kish commented that the Department received public feedback regarding last year's SB 1343 sexual harassment prevention training requirements and proposed forming a subcommittee to decide which topics regarding the sexual harassment prevention training requirements to focus on. He also noted that a pending bill, SB 778, may affect the effective date of SB 1343.

Councilmember Brodsky recommended the Council create a subcommittee to examine re-segregation trends.

The Council discussed a need for a second subcommittee member for the Employment Regulations Regarding Religious Creed and Age Discrimination Subcommittee, to which Councilmember Iglesias volunteered.

Chair Mandelbaum and Councilmember Chan volunteered to form the new SB 1343 subcommittee.

The Council moved, seconded, and unanimously voted to approve a motion to adopt the subcommittee assignments.
