NOTICE OF FURTHER MODIFICATIONS TO TEXT OF HOUSING REGULATIONS REGARDING DEFINITIONS; INTENTIONAL DISCRIMINATION; DISCRIMINATORY NOTICES, STATEMENTS, AND ADVERTISEMENTS; CONSIDERATION OF INCOME; RESIDENTIAL REAL ESTATE-RELATED PRACTICES; AND DISABILITY

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Fair Employment and Housing Council (Council) is providing notice of further changes made to sections 12005, 12042, 12140, 12141, 12050, 12176, 12179, and 12180 of Title 2 of the California Code of Regulations covering the Fair Employment and Housing Act. Text proposed to be added for this second 15-day comment period is displayed in wavy underline type. Text proposed to be deleted for this second 15-day comment period is displayed in italic and strikethrough type. In some instances, the text currently under consideration may be both single or double stricken and wavy underlined, which means it is text that was previously proposed to be deleted. Similarly, text that is either single or double underlined and italicized and stricken means that the text was previously proposed to be added, but the Council subsequently decided to remove it.
